EXCELLENCE IN HUMANITIES AWARDS

'Enriching the Humanities'

1. INTRODUCTION

The Faculty of Humanities of the University of Kelaniya, Sri Lanka intends to present the 'Excellence in Humanities Awards' for the first time in the history of the university to honour and celebrate outstanding contributions in the field of humanities by recognizing and acknowledging staff members who have contributed to enhance and develop the discipline in various ways. These areas will be recognised as areas of 'Excellence in Humanities'.

- 1.1. Date of awards ceremony: On the 1st of December every year.
- 1.2. Period under consideration: Activities of academics during the period between the 1st of August in the preceding year to the 31st of July of the current year will be rewarded.

2. ELIGIBILITY

- 2.1.1. The applicant should be a permanent academic staff member of the Faculty of Humanities, University of Kelaniya.
- 2.1.2. They must provide evidence of Google Scholar and ResearchGate profiles which have been made public in order to be eligible for the awards.
- 2.1.3. The applicant's institution should be mentioned as 'University of Kelaniya' in both profiles.

3. AWARDS

Excellence in Humanities will be recognized under eight (8) categories.

3.1. Creativity Excellence in Humanities

Work that will attribute to Section 2.3 of UGC Circular 916 and that has been nominated for recognized national and international awards in literature, culture, theatre, music, dancing, arts and design can be submitted for consideration.

- Number of awards: Three (3)
- up to 5 points/work

3.2. Scholarly Excellence in Humanities

Scholarly work that will attribute to Sections 2.1-2.2 of UGC Circular 916 (see table below) can be submitted for consideration.

3.3. Foreign Relations Excellence in Humanities

This award considers multiple kinds of international relations and MoUs which have helped progress humanities as a discipline, and using the University of Kelaniya as the base organization of the applicant.

Number of awards: One (1)

3.4. Reputational Excellence in Humanities

This award considers winning prestigious national or international awards, administrative positions in governmental or non-governmental organisations and research fellow positions. Applications will be considered under the following areas:

- 3.4.1. Winning prestigious national OR international awards
- 3.4.2. Administrative positions (for appointments in govt or non govt HEI¹s)
- 3.4.3. Research Fellow positions

Number of awards: Two (2)

3.5. Coordinating Excellence in Humanities

These awards are to be made to a department of study and not to individuals. The Head of the Department or the programme coordinator may apply on behalf of the group.

- 3.5.1. The first category of awards considers the following:
 - 3.5.1.1. number of foreign students
 - 3.5.1.2. *amount of foreign earnings* attracted to the university by the course/programme coordinated by the department.
- 3.5.2. The second category of awards considers the following:
 - 3.5.2.1. the *number of local students*
 - 3.5.2.2. *amount of local earning* attracted to the university by the course/programme coordinated by the department.

Number of awards: Two (one from each category)

3.6. Coordination Excellence in Humanities

The applicants must be coordinators of centres/units/committees in the faculty, who have served at least 9 months during the period under review (e.g. 1st of August 2022 to 31st of August 2023) and have completed more than 75% of the activities listed in the Action Plan 2022 approved by the faculty. The application has to be recommended and approved by the Director of the centre/unit/committee the coordinator is attached to and endorsed by the Dean of the faculty. The application must bear evidence of initiation and implementation of the activities listed by the applicant, endorsed by the Dean of the faculty.

3.7. Service Excellence in Humanities

This award recognizes distinguished services provided by the academics in the Faculty of Humanities to the University of Kelaniya. This award is attributed to Section 3 of the UGC Circular 916 (See table below)

3.8. Contribution Excellence in Humanities

This award considers outstanding members in a department of the Faculty of Humanities, who have contributed to the educational programme.

- *3.8.1.* This award is attributed to Section 1.6 of the UGC Circular 916.
- *3.8.2.* A self -assessment report signed and approved by the HOD should be submitted with supporting documents/evidence

4. APPLYING

- a. A member of the academia in Humanities may apply for more than one award.
- b. For categories **3.1** and **3.2**, the work in an appropriate format shall be submitted with the covering letter (Annex 1) and relevant supporting evidence.
- c. For categories **3.3 and 3.4** applicants should provide a detailed self-evaluation report (maximum 500 words) of what he/she has achieved/done in the relevant category with evidence.
- d. For category **3.5**, the application should contain a detailed report (maximum 500 words) of what the department has achieved in the relevant category with evidence.
- e. For category **3.6**, applicants should provide supporting evidence from the relevant departments, certified by the relevant Head and Dean, along with a detailed self-evaluation report.
- f. For category **3.7**, the applicant should provide a self-evaluation report (maximum of 500 words) of what he/she has achieved in the relevant category with evidence.
- g. For category **3.8**, the applicant should allocate a self-evaluation mark for each of the sections in the table provided together with relevant evidence. The applications should be endorsed by the relevant Head and Director/Dean.
- h. The deadline for applications will be on a date which is minimum of four weeks and a maximum of six weeks from the date of announcement of the awards. The deadline may

be extended by the Dean with the approval of the Faculty Board. In such event, the extension will be applicable for all eight categories.

i. The applications shall be accepted by the Dean's office with a date stamp.

5. SELECTION

Selection panel

- a. The Dean shall propose a six-member selection panel.
- b. Four members shall be the members of the Faculty academia and two members shall be from other faculties of the University (external members).
- c. Any of the nominees to the selection panel should NOT have applied for the award for a given year and should have no conflict of interests (Annex 2).
- d. One member of the faculty academia and the external members shall be proposed as the co-chairs of the committee.
- e. The proposed members and co-chairs shall be approved by the Faculty Board of Humanities.

Selection for awards

- a. The selection panel shall complete the review within a maximum of four weeks of their appointment.
- b. All applications of all categories shall be reviewed by all members of the panel independently. In the evaluation, the following aspects shall be considered and the marks shall be assigned as follows:

- c. The awardees shall be nominated through consensus or the majority's vote of the selection panel. In either situation, the final decisions shall be endorsed by the entire panel.
- d. The selection panel has the right to not nominate awardees for a particular category if the applications are not up to the standards expected by the selection panel.
- e. The list of awardees shall be handed over to the Dean by co-chairs and Dean shall table it at the Faculty Board Meeting.
- f. The decision of the Selection Panel shall be the final decision.
- g. The award ceremony shall be in the form agreed by the faculty board.
