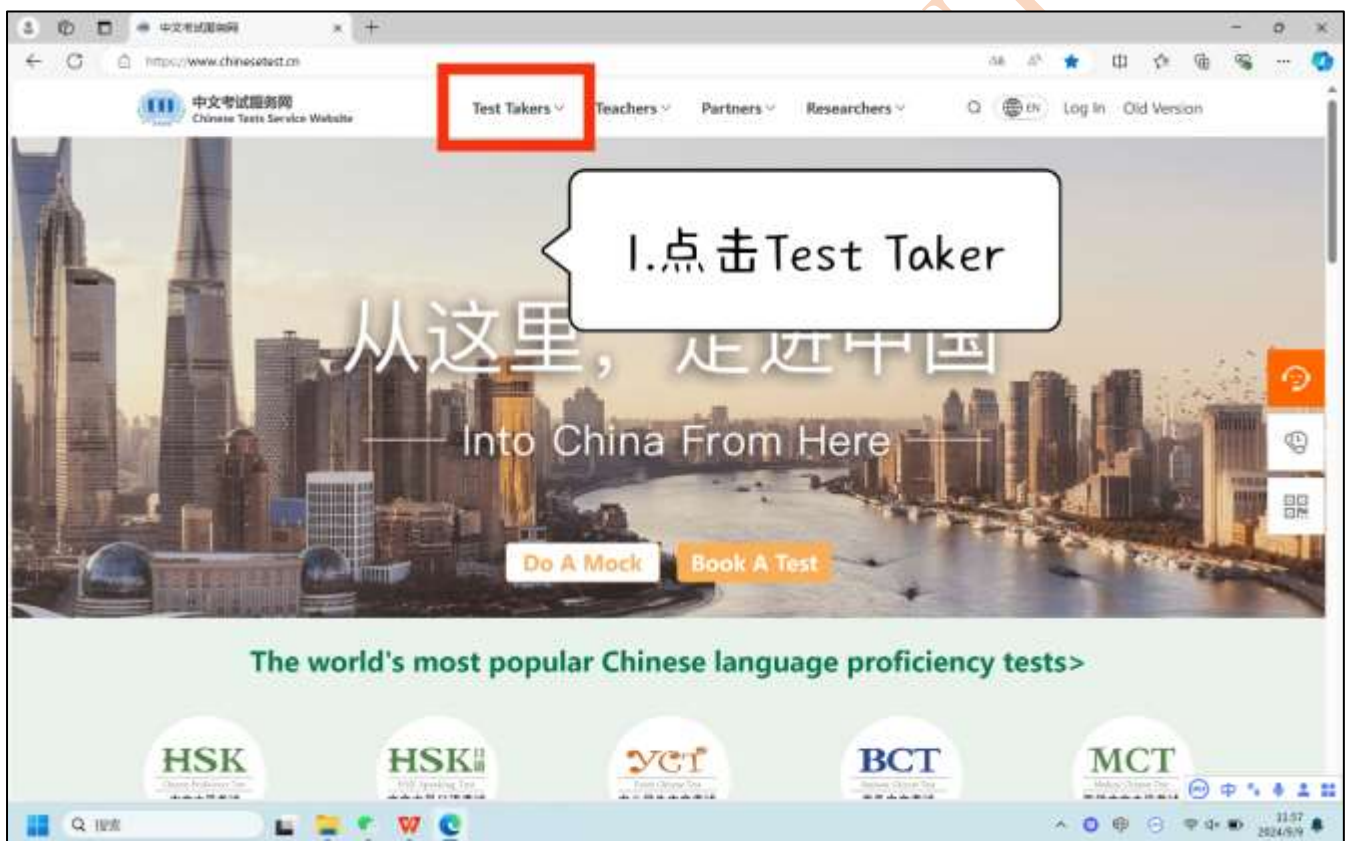


Guidelines for Online Registration of HSK Examination

1st Step

1. First, log in to the website using the following link

<https://www.chinesetest.cn> and, then click on “Test Takers”.



2nd Step

2. Click on the “**HSK**”.



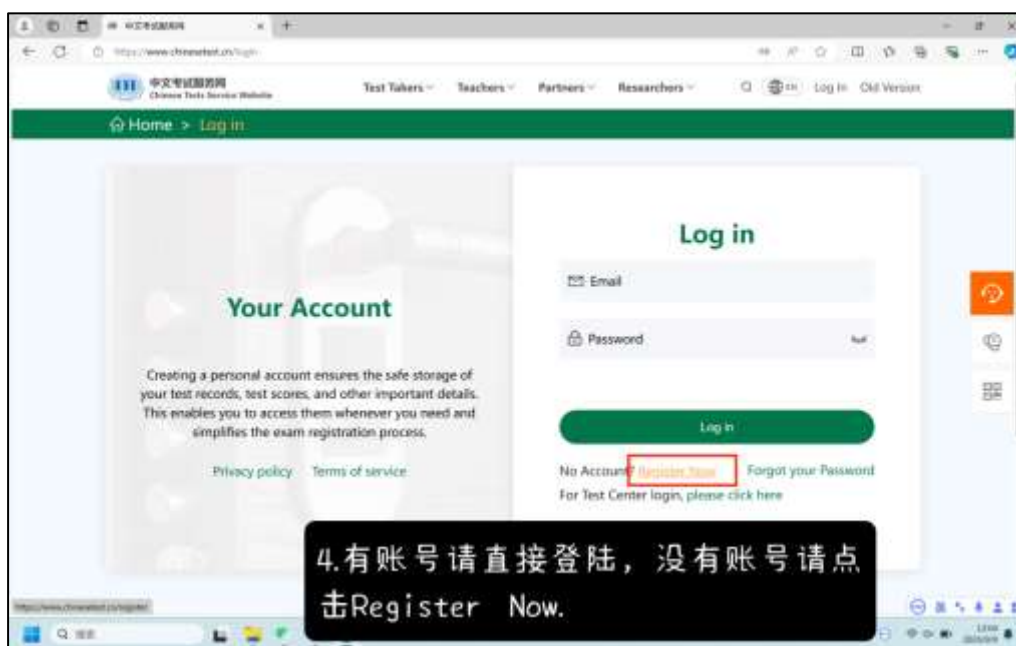
3rd Step

3. Next, Click the “**Book A Test**”



4th Step

4. If you already have an account, you can use your email and password to log in directly. If you don't have an account, to create a new account, you must click on **“Register Now”**.



5th Step

5. Then enter your details and verify them after entering your account details. (Drag the slider to the right to fill the puzzle)



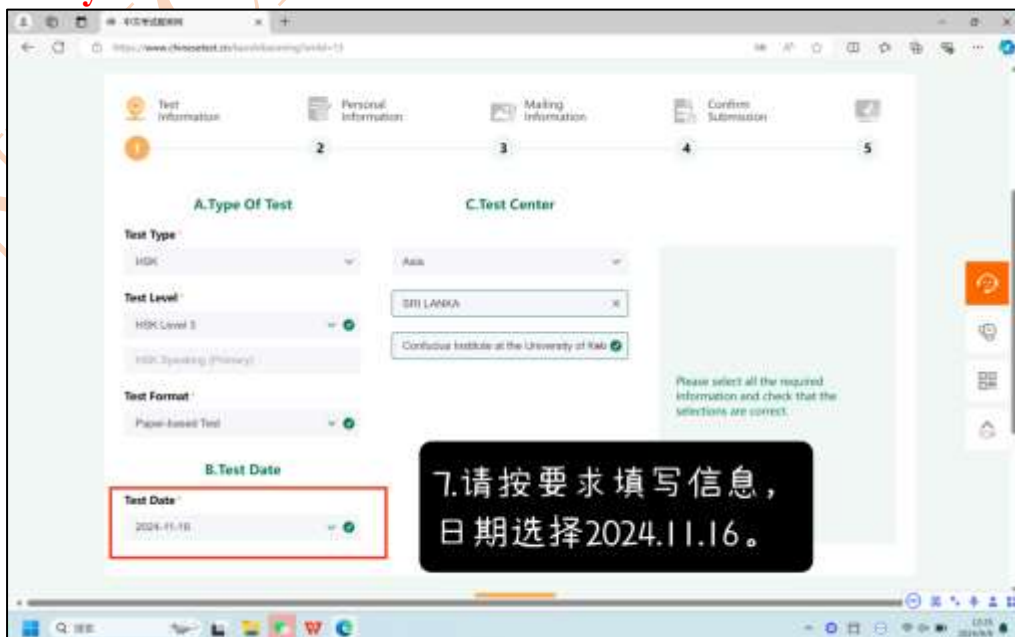
6th Step

6. After verification is completed and login is successful, then click on “**Book A Test**”.



7th Step

7. Select answers to **A**, **B**, and **C** correctly. Select the test date as **November 16, 2024**, and the test center should be the **Confucius Institute at the University of Kelaniya**.



8th Step

8. After filling in the information, click on “Next” and continue to select “Submit”.

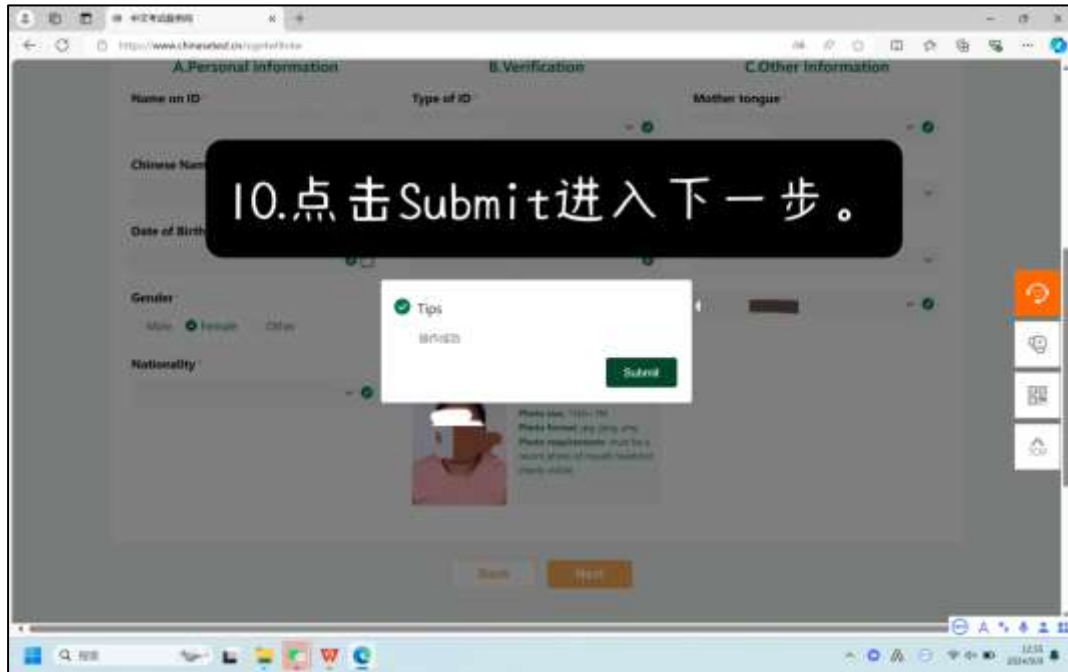
9th Step

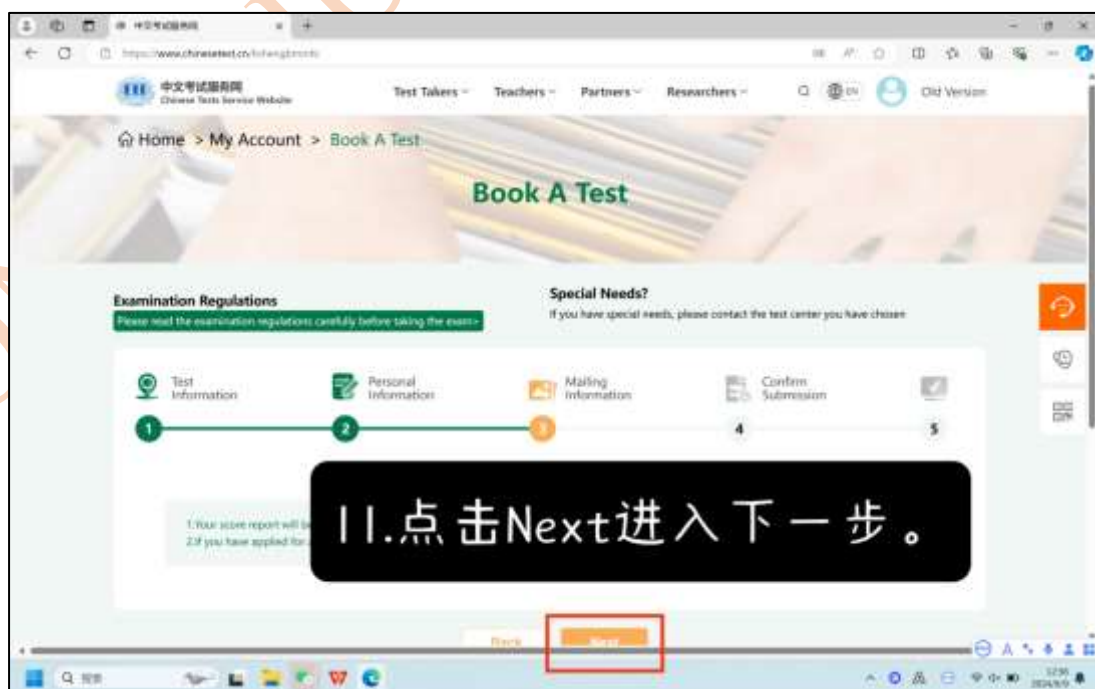
10th Step

10. Click on **“Submit”** to proceed to the next step. Then, Click on **“Next”**.




11th Step

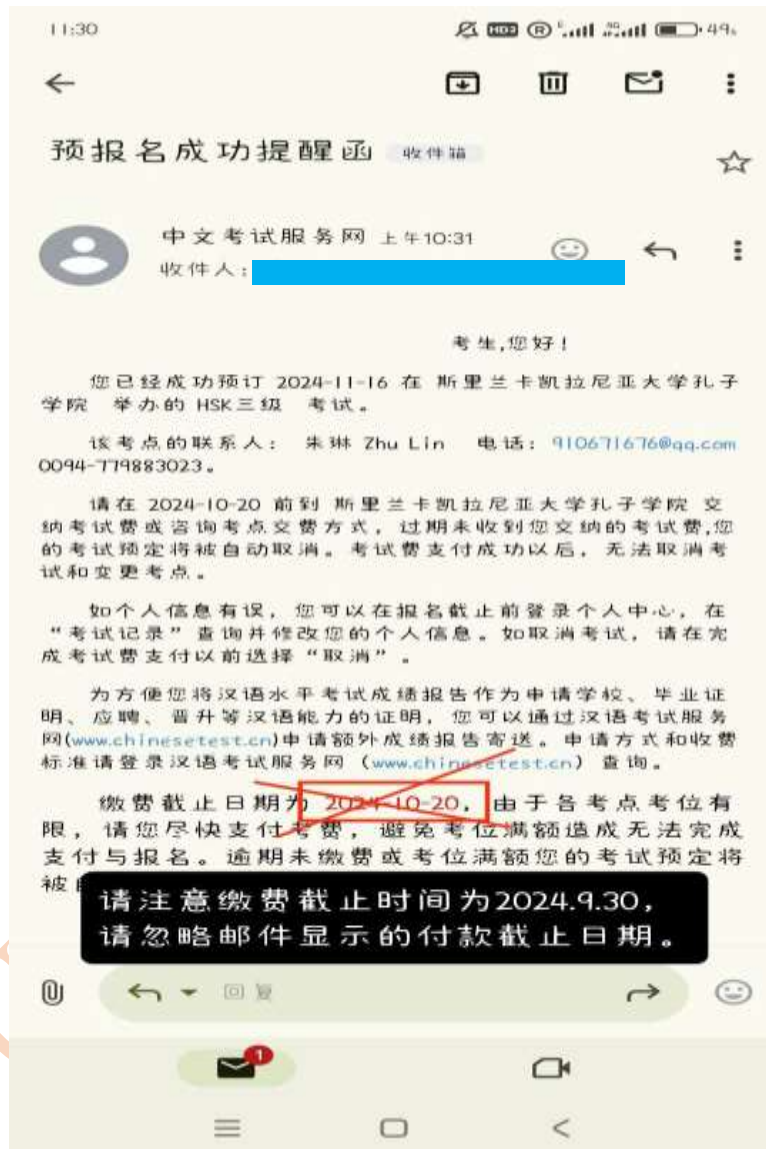
13. If you have already registered successfully, you can see the following mentioned interference.
